- (i) Pontoons. Again we are asking for some form of temporary ones to be put in.
- (ii) Main slipway still needs repairing. Filling it with concrete does not appear to be the answer.
- (iii) The dredging has been a success but it now needs to move along the wall
- (iv) Can the slipway at the far end of the promenade be repaired
- (v) The sewer pipe still needs urgent attention. Can we put pressure on the water board,
- (vi) Rod fishing from the harbour wall should be policed more.
- (vii) Block work on harbour is still in a very bad state. As soon as it rains there are large puddles, this is getting worse especially around the ferry shed electric post.
- (viii) The hole on the diesel area is getting much worse
- (ix) Fendering on the ladders. Ladders need securing. Old ironwork was damaging boats
- (x) More rings are needed for tying up boats
- (xi) Toilets have been painted but the lighting is still appalling
- (xii) Mobil homes on the promenade caused major problems on the road last season
- (xiii) Beach patrol wages. Where do they come from?
- (xiv) Can the paper work be sent out earlier in order to get mooring inspected in time?
