- **Isafswm / Minimum** means that at least 95% of the samples meet the mandatory standards of the Directive; limits used are TC: =10000; FC: =2000; FS: N/A.
- **Methu / Fail** means that fewer than 95% of the samples meet the required mandatory standards of the Directive; limits used are TC: >10000; FC: >2000; FS: N/A.
