**PROMENADE BYELAWS**

## PROMENADE BYELAWS

Byelaws made by the District Council of Meirionnydd under  
Section 83 of the Public Health Acts Amendment Act 1907

1. For the purposes of these byelaws the following expressions shall have the following meanings:
  - (a) 'The Promenade' means:
    - (i) All that pedestrian walkway at Barmouth extending from the Bath House in northerly direction for a distance of approximately 2200 meters to a point opposite Fronoleu.
    - (ii) All that pedestrian walkway at Barmouth extending from a point approximately 138 metres north of the Bath House in a south westerly direction for a distance of approximately 474 metres.
    - (iii) All that pedestrian walkway at Tywyn extending from the western end of Pier Road in a northerly direction for a distance of approximately 900 metres to a point north to Brynymor Caravan Site.
    - (iv) All that pedestrian walkway at Tywyn extending from the western end of Pier Road in a southerly direction for a distance of approximately 490 metres to Warwick Place but excluding a strip 3.5 metres in depth abutting Marine Parade.
    - (v) All that pedestrian walkway at Tywyn extending from the western end of Warwick Place Road in southerly direction for a distance of approximately 370 metres.  
All which pedestrian walkways are delineated for the purpose of identification only on the plans attached to these byelaws and thereon coloured red.
  - (b) 'Premises' means any building or construction in the nature of a building, including more particularly but without prejudice to the foregoing general words any café, shop, store or kiosk.
  - (c) 'Foreshore Pitch' means any part of the foreshore designated by the District Council for the sale of goods or services by persons holding concessions from the District Council.
2. No person shall ride, drive or park any vehicle drawn or propelled by any mechanical power or ride a bicycle, tri-cycle, cyclomobile, skateboard or similar machine or ride a horse on any part of the Promenade  
Provided that this byelaw shall not apply:
  - (i) to any person in the service of the local authority for the purpose of collecting refuse, either for sweeping or for any purpose connected with the maintenance, repair, reconstruction or improvement of the Promenade or seawall or for any purpose connected with the laying out maintenance and gardening works to any ornamental gardens on or abutting the Promenade;
  - (ii) for the purpose of transporting goods and equipment to or from any premises on or abutting the Promenade or any foreshore pitch only for the purpose of loading or unloading any such goods and equipment;
  - (iii) for the purpose of any emergency in connection with the saving of life;
  - (iv) for the purpose of access at all times for the emergency service vehicles of the police, fire and ambulance;
  - (v) for the purpose of direct access to the slipways for launching recovering servicing and maintaining any boat or craft from any road to any of the slipways on the foreshore;
  - (vi) to any person bona fide riding, driving or parking an invalid carriage on the promenade;
  - (vii) to any residents who are bona fide going to or from their premises abutting on the promenade.

3. No person shall by operating or causing or suffering to be operated any wireless set, gramophone, amplifier, tape recorder or similar instrument or any musical instrument make, cause or suffer to be made any noise which is so loud or so continuous or repeated as to give reasonable cause for annoyance to other persons on the promenade.
4. No person shall take part in any game or other activity on the Promenade so as to knowingly cause danger or to give reasonable cause for annoyance to any other person on the Promenade.
5. Any person offending against any of the foregoing byelaws shall be liable on summary conviction to a fine not exceeding One Hundred Pounds.
