## **CONSULTATION**

The application was consulted upon and comments and objections to the application were received from the owner of a near by business and Bangor City Council. An objection to the application was initially received from North Wales Police, but following discussions with the applicant there was an agreement subject to specific conditions.

### **Police's Objection**

Following discussions with the applicant, the Police have noted that the applicant has agreed to limit the licensable activities to 03:00 Sunday to Thursday, and 03:30 on Fridays and Saturdays. The agreement of the Police to support the application is subject to the applicant's agreement to accept additional conditions in respect of CCTV, and the employment of door supervisors in respect of the terminal hour of licensable activities on Thursday, Friday and Saturday nights.
