- 1. At its meeting on the 15th July, 2010, whilst discussing the new Planning Committee the Council decided as follows regarding allowances "Approve the amendments to the Members Allowances Scheme as outlined in paragraphs 10 to 12 in the Monitoring Officer's report and present a formal application to the Independent Remuneration Panel for authority to pay the special responsibility allowance to the Chairman of the Area Committee."
- 2. An application made to the Independent Panel was successful. In Appendix 1 there is a copy of the Panel's letter confirming this.
- 3. In view of this and the Council's desire for the Area Committee Chairman to receive a special responsibility allowance, there is a need to consider the Allowances Scheme. The amended Allowances Scheme can be seen in Appendix 2. It is suggested that the allowance to the Area Committee Chairman be paid on the same scale at the Scrutiny Committee Chairman which is £4,546 per annum.
- 4. The total cost for the three Area Committees is £13,638. In order to meet this cost within the budget, it would be necessary to reduce other allowances. The only other option for the Council would be to a bid forward for consideration in the context of all other bids for 2011/12 onwards.

RECOMMENDATION.

5. It is recommended that the Council amends the Members Allowances Scheme in accordance with Appendix 2 in order to pay an allowance of £4,546 to the Chairman of the Area Committee and to present a financial bid to be considered in the context of the remainder of the Council's budget from 2011 onwards.

APPLICATION FOR THE PAYMENT OF ADDITIONAL SPECIAL RESPONSIBILITY ALLOWANCES

Thank you for your e-mail of 27th August attaching your Council's application to extend its scheme of allowances in respect of Special Responsibility Allowances (SRAs). The Independent Remuneration Panel for Wales considered the various applications received from local authorities at its meeting on 3rd September. I am writing to inform you of its decision concerning your application.

The Panel has agreed to your Council's request for the following posts to be made eligible to receive an SRA, in the following band:-

Chair of Arfon Area Committee - Band 3
Chair of Dwyfor Area Committee - Band 3
Chair of Meirionnydd Area Committee - Band 3

This agreement is on the understanding that these additional SRA payments will not take your Council over the 50% maximum limit as set out in the Local Authorities (Allowances for Members) (Wales) Regulations 2007. It is also on the understanding that the postholders are not already in receipt of an SRA payment.

The payments may be backdated to the start of the current financial year, or the date when each post-holder took up their position, whichever is appropriate.

A Supplementary Report, which will provide information on successful applications, is being prepared and will be published as soon as possible.

MEMBERS ALLOWANCES SCHEME

1 APRIL 2010 TO 31 MARCH 2011

Gwynedd Council in exercise of the powers given to it by the Local Authorities (Allowances for Members) (Wales) Regulations 2007, hereby make the following scheme:-

1. This scheme may be called the Gwynedd Council Members' Allowances Scheme, and it will be in force for the year ending on the 31st March, 2011 and subsequent years.

2. **Definitions.**

In this scheme

- 2.1 "Council" means Gwynedd Council
- 2.2 "Councillor" means a member of the Council who is a councillor
- 2.3 "Year" means the 12 months which ends on the 31 March.
- 2.4 "Proper Officer" means the Head of Democracy and Legal
- 2.5 "Panel" means the Independent Remuneration Panel for Wales
- 2.6 "Member" includes a councillor and a co-opted member
- 2.7 "Co-opted member" means a person who is not a councillor but who is a member of a committee of the authority and who is entitled to vote.

3. Basic Allowance.

- 3.1 A basic allowance will be paid to every councillor.
- 3.2 Not more than one basic allowance is payable to any councillor.

4. Special responsibility allowance.

- 4.1 A special responsibility allowance will be paid to the following councillors in respect of their posts as denoted below:-
 - 4.1.1 The Chairman of the Board/Council Leader
 - 4.1.2 Senior Leader
 - 4.1.3 Portfolio Leader
 - 4.1.4 The chair of the Principal Scrutiny Committee the other scrutiny committees and the area committees.
 - 4.1.5 The chair of the Audit, and Licensing committees
 - 4.1.6 From October 2010, the chair of the Planning Committee.
- 4.2 Not more than one special responsibility allowance is payable to any councillor.

5. Care Allowance.

- 5.1 A care allowance will be paid to councillors in connection with expenditure necessarily incurred by them for the care of children or dependants to enable them to fulfil their duties as councillors and conditional upon a successful application for the allowance being made in accordance with terms set from time to time by the Council.
- 5.2 A care allowance is not payable to more than one councillor in relation to the care of the same child or dependant.
- 5.3 A care allowance is not payable in relation to the care for a child who is over 15 years old.
- 5.4 Not more than one claim can be made by any one councillor.

6. <u>Co-optees allowance.</u>

6.1 A co-optees allowance will be paid to co-optees who chair the Standards Committee, who are members of the standards committee or who are members (for education purposes) of the Children and Young Persons Scrutiny Committee.

7. Travelling and Subsistence Allowances.

7.1 Travelling and subsistence allowances will be paid to members where expenditure has been necessarily incurred on travelling or subsistence in connection with approved duties and upon receipt of a valid claim in accordance with the Council's guidance on claiming travelling and subsistence allowances.

8. The amount of allowance.

- 8.1 The amount of every allowance will be set from time to time by the Council and will appear in the schedule to this scheme.
- 8.2 The amount of the allowance will not be greater than the sum prescribed by the Panel in an annual report or a supplementary report in connection with that allowance for the year in question.
- 8.3 The amount of the allowance will be adjusted in April every year in line with the adjustments prescribed by the Panel for that allowance for that year.

9. Renunciation.

9.1 A member may elect to forego any part of his/her entitlement to an allowance under the scheme by notifying the proper officer in writing.

10. Suspension.

Where a member has been suspended or partly suspended from fulfilling his/her responsibilities or duties as a member of the Council in accordance with Part III Local Government Act 2000 or regulations made under that Part, the Council will withhold payment of that part of the allowance as is payable to the member in relation to the responsibilities or duties from which that member is suspended.

11. Amendments and part year claims.

- 11.1 The Council may amend or revoke this scheme at any time. If an amendment affects an allowance payable for the year in which the amendment is made, then (unless the Council decides to the contrary) the entitlement to such allowance will take effect from the beginning of the year in which the amendment is made.
- 11.2 The effect of the following provisions of this paragraph is to manage the entitlement of councillors to basic or special responsibility allowances where this scheme is revised during the course of the year or where the councillor becomes a councillor or ceases to be a councillor during the course of a year.
- 11.3 If the revision of this scheme changes the sum to which a councillor is entitled as a basic or special responsibility allowance, then in relation to each of the periods
 - (a) beginning with the year and ending on the day preceding the day of which the revision comes into force in that year, or
 - (b) beginning with the day on which the revision comes into force and ending on the day preceding the day on which the next revision comes into force or (or if there is no revision) with the year.

the member's right to such an allowance will be the entitlement to receive that part of the allowance under this scheme to which he/she is eligible during the relevant period and which is the same percentage of the total sum as is the number of days in that period to the number of days in the year.

- Where a member's term in office begins or ends other than at the beginning or the end of the year, his/her entitlement to a basic or special responsibility allowance will be the entitlement to receive that part of the allowance which is the same percentage of the total sum as is the number of days he/she is in office to the number of days in that year.
- 11.5 Where this scheme is revised in accordance with sub-paragraph 11.3, and where a councillor's term in office does not last throughout the term noted in sub-paragraph 11.3(a), his/her entitlement to a basic or special responsibility allowance will be the entitlement to receive that part of the allowance which can be ascribed to each such term (decided in accordance with that sub-paragraph) which is the same percentage of the total sum as is the number of days he/she is in office, to the number of days in that period.

12. Claiming and receiving payments.

- 12.1 A written claim must be submitted for travelling and subsistence allowance by the end of the first full week following any month. These allowances will not be paid for any month except for the two calendar months immediately preceding the submission of the claim. The proper officer is authorised to allow late applications in exceptional cases of illness or long term absence.
- 12.2 A claim for allowances must include, or have attached to it, a statement by the member claiming the allowance that he/she has not, and will not, make any claim in respect of the matter referred to except under this scheme.
- 12.3 Allowances will be paid monthly on a date stipulated by the proper officer and in twelve instalments in the case of basic, special responsibility and co-optees allowances.
- 12.4 Where the entitlement to receive an allowance begins or ends during a month the payment to the member must be adjusted in order to ensure that the sum received during the year does not exceed the sum to which he/she is entitled under paragraph 11.
- 12.5 A written claim must be submitted for a care allowance by the end of the first full week following any month and receipts for the expenditure must be attached.
- Where an allowance has already been paid in relation to any period when the member is suspended or partially suspended or ceases to be a member of the Council, or is not entitled in any other way to receive the allowance in relation to that period, the Council will require repayment of that part of the allowance as appertains to that period.
