- 1. There are 9 members on the Standards Committee, namely 3 councillors from Gwynedd Council, 1 member representing Community Councils and 5 independent members.
- 2. There is a need to appoint one Councillor from Gwynedd Council to the committee to replace Councillor Stephen Churchman who has become a member of the Council Board. This appointment is not made on the basis of political balance. A copy of the requirements of the post is at Appendix 'A'.
- 3. Following an open invitation to all Council members (with the exception of Board members) to serve on the Standards Committee, an expression of interest was received from 3 members.
- 4. In accordance with the arrangements approved by the Council the political group leaders met to consider the applications.
- 5. Using the criteria set out for Standard Committee members, together with the contents of the application and experience, the Leaders recommended to the Council that Councillor Eryl Jones-Williams should be appointed to serve on the Standards Committee.

6 **RECOMMENDATION.**

The Council is asked to appoint Councillor Eryl Jones-Williams to serve on the Standards Committee for the remainder of the term of this Council.
