- 3. As is clear from the above, we have sought to follow an extensive and inclusive process with particular attention to improving the Council's capacity to commit to and deliver real benefits for residents.
- 4. Crucially, as the work on the Plan comes to a close, there has been scrutiny of the individual programme plans by the Scrutiny Committees and also consideration of the resource implications by the Principal Scrutiny Committee. The work of developing the detailed plans is almost complete and the most recent draft copy of the Plan is attached. I should note that it is likely that there will still be a need for some last minute improvements to be made before its publication.
- 5. On 3rd May, 2011, the Council Board considered the resource requirements linked to the commitments in the Plan and it approved the necessary allocations within the resources made available by the Council for this purpose. Indeed, the Board's decisions mean that a significant portion of those resources remains to be allocated. Dicsussions are continuing about the funding of some projects and it may be necessary to allocate further resources but those will be considered and decided upon as required, subsequently when those discussions have been completed.
