The Chairman signed the minutes of the previous meeting of this committee, held on 16 September 2016, as a true record.

#### 5. EXCLUSION OF PRESS AND PUBLIC

#### 6. DRAW UP A SHORT LIST FOR APPOINTING A HEAD OF REGULATORY DEPARTMENT

The Chairman reported that five applications had been received for the post and that this was encouraging.

In response to a question regarding the costs of holding an assessment centre, the Head of Corporate Support Department confirmed that the costs of the Assessment Centre were not calculated on the basis of cost per head and the Chief Executive noted that holding an assessment centre was central to the process of appointing Heads in order to ensure quality and receive an independent view. The cost of making an incorrect decision would be much higher for the residents of Gwynedd.

The applications were discussed in accordance with the requirements of the post, focusing on the main competencies.

#### RESOLVED TO PLACE FOUR CANDIDATES ON THE SHORTLIST

Members were reminded that the interviews would be held on 8 November 2016 and it was agreed to extend an invitation to the relevant Cabinet Member.
