Item 6: FUTURE OF PRIMARY EDUCATION PROVISION IN THE BANGOR CATCHMENT AREA

DECISION

Resolved:

- i. Hold a statutory consultation, in accordance with Section 48 Schools Standards and Organisation (Wales) Act 2013, in the Bangor catchment area on the proposal to close Ysgol Glanadda and Ysgol Coedmawr on 31 August 2020, and offer a place to the pupils at Ysgol y Garnedd (subject to parental choice); and increase the capacity of Ysgol y Garnedd to 420.
- ii. Hold a pre-consultation with the Church in Wales regarding increasing the capacity of Ysgol y Faenol to 315 in accordance with the School Organisation Code 2013 requirements and report on the results to the Cabinet.

REASONS FOR THE DECISION

The Council has implemented the 'Primary Education of the Best Quality for the Children of Gwynedd' Strategy since its adoption in April 2009. At the end of 2016, Welsh Government announced that there was an opportunity for Local Authorities with the capacity to fulfil additional projects within Band A 21st Century Schools Programme. An additional request was submitted to the Government and confirmation was given that funding had been agreed in principle. This confirmation enabled the Council to review current provision in Bangor.

Statutory processes need to be undertaken in order to proceed with subsequent proposals and as an initial step a decision needs to be taken on commencing consultative processes in accordance with the Act and statutory guidance.
