17	<p>EXCLUSION OF PRESS AND PUBLIC</p> <p>The Chair shall propose that the press and public be excluded from the meeting during the discussion on the item following due to the likely disclosure of exempt information as defined in Paragraph 14 of Schedule 12A of the Local Government act 1972 Information relating to the financial or business affairs of any particular person (including the authority holding that information).</p> <p>There is an acknowledged public interest in openness in relation to the use of public resources and related financial issues. It is acknowledged however that there are occasions, in order to protect the financial interests of public authorities that matters related to commercial information need to be discussed without being publicised. The report relates specifically to contracting with a Commercial business in relation to grant funded projects. The nature of the information is sensitive to the company and its publication could affect their commercial interests. The publication of commercially sensitive materials of this kind could also undermine the confidence of grant applicants to approach the Council. This would undermine the public interest of allowing frank and thorough discussions with applicants for financial support.</p>
