It was decided to write to the Minister for Education, firstly to thank her for her announcement of 10 November on the arrangements for awarding qualifications in 2021, and to note concerns arising from the meeting.

It was decided to write to Geraint Rees, Chair of the Design and Delivery Group, outlining the concerns noted.

REASONS FOR THE DECISION

On Monday 17 August 2020, Kirsty Williams, Minister for Education, confirmed that A level, AS, GCSE, Skills Challenge Certificate and Welsh Baccalaureate grades in Wales are now awarded on the basis of Centre Assessment Grades.

In the Children, Young People and Education Committee the Minister noted that she will commission an independent review of the arrangements for awarding grades in the summer 2020 examination series, and the considerations for 2021.

It was noted there needs to be a discussion to consider any further response required following the Minister for Education's statement on 10 November 2020 in relation to the Independent Review, and to consider what support schools need to implement the recommendations effectively.
