1. <u>APPLICATION RECEIVED</u>

- 1.1 An application is attached for a premises licence for Abersoch Diner, High Street, Abersoch, L153 7DY from the applicant Gavin Hancock. The applicant is seeking to vary an existing premises licence for a single-storey dining room for 30 people.
- 1.2 The application is made in relation to extending opening hours, hours of the sale of alcohol (on the premises only) and the provision of recorded music on the premises.
- 1.3 Officers from the Licensing Authority are satisfied that there is sufficient evidence that the application has been submitted in accordance with the requirements of the Licensing Act 2003 and the relevant regulations and is therefore valid.
- 1.4 Several objections to the application have been received from members of the public, and the applicant has agreed to public protection conditions in terms of a compromise to not use the outdoor area after 6pm. Police and the Fire and Rescue Service had no observations or objections.

2. <u>Measures recommended by the applicant to promote the licensing objectives</u>

Measures recommended by the applicant include the following -

- The challenge 21 policy will be adhered to in relation to the sale of alcohol and there will be no sale of alcohol off the premises.
- Staff training on the sale of alcohol, child protection policy and disorder
- Zero-tolerance policy towards drugs and drink will be adopted
- Fire protection system and alarms will be installed and serviced regularly

3.2 <u>Members of the public and neighbouring residents</u>

Nine e-mails have been received objecting to the application based on the licensing objectives of:

- Public nuisance prevention
- Public safety
- Prevention of crime and disorder

Concerns were expressed regarding anti-social behaviour issues in terms of noise, public nuisance, sanitary issues and crime and disorder. There were also concerns that the premises was close to the main road, a lack of parking and close to residents. There were several comments in respect of the presence of too many licensed premises already in this area.

3.3 Local Councillor

The application is unclear in relation to the use and purpose of the building, and concerns about noise and public nuisance for neighbouring residents if the outdoor area is used, were expressed.

3.4 Llanengan Community Council

Concerns about noise and public nuisance for neighbouring residents if the outdoor area is used, were expressed.

3.5 <u>Public Protection</u>

Observations and conditions have been received from the Public Protection Department. The applicant agreed to compromise to not use the outdoor area after 6pm due to concerns about noise, that windows and doors must be closed when music is playing , which must be at a background noise level only.

4 <u>RECOMMENDATION</u>

It is recommended that this Committee approve the application - in accordance with what was agreed with the Public Protection service; and in accordance with the requirements of the Licensing Act 2003.
