DECISION Annual Monitoring Report 5 (Appendix 1) was accepted and it was agreed to present it to the Government by the end of October 2023.	
REASONS FOR THE DECISION The Town and Country Planning (Local Development Plans) (Wales) Regulations 2005 sets out the need to monitor the Local Development Plan annually and to present the Annual Monitoring Report to the Welsh Government by 31 October every year. The Cabinet had decided in June 2022 to terminate the collaboration agreement on planning policy matters with Isle of Anglesey County Council. This decision meant that the Joint Planning Policy Committee, which made decisions on planning policy matters, including the Annual Monitoring Report, also came to an end. The report was submitted to the Cabinet in June 2023, where the new Governance Arrangement for the New Local Development Plan and other Planning Policy matters were agreed. As a result of this decision, the Annual Monitoring Report had been presented to the new Planning Policy Working Group for observations for consideration by the Cabinet. The intention of this Report therefore is to present the fifth Annual Monitoring Report which relates to the period between 1 April 2022 - 31 March 2023, and the Working Group's observations, for observations and a decision by the Cabinet to send the Report to the Welsh Government by 31 October 2023.
