APPLICATION

An application for a premises licence for Pant yr Ardd, Tregarth, Bangor was received on 22 May 2015 from Mr Kenneth Richard Williams. A copy of the application and premises plan is available in Appendix 1.

The applicant explains in the application that this is an application for a public house with beer garden, however, the plan received with the application does not specify the location of the beer garden. A summary of the proposed licensable activities and opening hours of the premises is available in Appendix 2.

The steps the applicant intends to take to promote the four licensing objectives are listed in section M of the application.

BACKGROUND INFORMATION

A premises licence did exist for this premises from 24 November 2005 however it was surrendered on 20 May 2015. A summary of the previous opening hours and licensable activities is provided in Appendix 3.

Following discussions between the Environmental Health service, the Licensing Authority and the applicant, the applicant has agreed to the noise and CCTV conditions being included in the premises licence.

The representations received from the 5 other interested parties were objections to the application. Their objections are based upon the licensing objectives of Prevention of Crime and Disorder and the Prevention of Public Nuisance. The residents main concerns are the increase in noise, disorder and littering if this application was successful.

RECOMMENDATION

The sub-committee is requested to consider the application for a premises licence in accordance with the objectives of the Licensing Act 2003.
