1. APPLICATION RECEIVED

- 1.1 An application is attached for a premises licence for Y Crochan, 9-11 Hole in the Wall Street, Caernarfon, Gwynedd, LL55 1RF. The applicant MUNCHIO (limited company) is seeking a premises licence for a restaurant that will serve food across three floors, with the option of having a meeting room on the third floor.
- 1.2 The application is made in relation to the sale of alcohol on and off the premises.
- 1.3 The officers of the Licensing Authority are satisfied that there is sufficient evidence that the application has been submitted in accordance with the requirements of the Licensing Act 2003 and the relevant regulations, and is therefore valid.
- 1.4 Several objections to the application were received from nearby residents, including members of the residents association. The Police and the Fire and Rescue Service had no observations or objections.

- Staff to be trained on the sale of alcohol, implementing the 25 proof of age scheme and keeping a record of refusals
- Adherence to fire safety policies under the supervision of the local fire safety service
- Ensure that deliveries are made at appropriate times and that bins are emptied so as not to disrupt neighbouring residents
