ROAD TRAFFIC REGULATION ACT 1984
SECTION 14(1) AS AMENDED BY THE ROAD TRAFFIC
(TEMPORARY RESTRICTIONS) ACT 1991
THE GWYNEDD COUNCIL
(CLOSURE OF THE CLASS II ROAD KNOWN AS
CARNEDI ROAD, BETHSDA)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2021
NOTICE IS HEREBY GIVEN that the Gwynedd Council intend not less than seven days from the date hereof to make an Order, the effect of which will be to prohibit any person from causing any vehicle to proceed in either direction along that length of Class II Road known as Carnedi Road, Bethesda for a point directly opposite no. 1 Gode'r Gaer, Carnedi Road, Bethesda.
 The Order is necessary on health and safety grounds to the public during the laying of a new crossing along the road.
 The alternative route from a point near to the closure near no. 1 Gode'r Gaer is to follow the road in a north westerly direction along Carnedi Road for a distance of approximately 122 metres up to its junction with Ffrydas Road and then turn left. Continue along Ffrydas Road for a distance of approximately 144 metres up to its junction with Penybryn Road and then turn right. Proceed along Penybryn Road for a distance of approximately 230 metres up to its junction with Pant Glas Road and then turn left. Follow Pant Glas Road in a south easterly direction for a distance of approximately 225 metres up to the crossroads and then straight on along Gerlan New Road for a distance of approximately 270 metres up to its junction with Carnedi Road. Turn left, following Carnedi Road in a north westerly direction for a distance of approximately 390 metres back towards the closure and vice versa for vehicles travelling in the opposite direction.
 The Order comes into effect on the 8th November, 2021, and will continue in force for a period not exceeding one month or until the work which it is proposed to carry out on the road is completed, whichever is the earlier. At this stage it is anticipated that the work will be completed within approximately 5 days.

LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982
 Notice is hereby given that Gwynedd Council ("the Council") on 7 October 2021 resolved to adopt Schedule 3 ("the Schedule") of the Local Government (Miscellaneous Provisions) Act 1982, as amended by section 27 of the Policing and Crime Act 2009, with effect from 1 December 2021. This Schedule enables the Council the power to regulate and license sex establishments within the county. The Council is authorised to prescribe standard conditions which will be presumed to apply to all Licences which it issues, as well as charge reasonable fees in respect of applications for such Licences.

 The Schedule makes it an offence for a Licence holder to fail without reasonable excuse to display his Licence. Any person who commits this offence shall be liable upon summary conviction to a fine not exceeding level 3 on the standard scale (currently £1,000.00).
