## 1. THE DECISION SOUGHT

The Council is asked to:
1.1 adopt the list of committees and sub-committees to be established for the 2022/23 municipal year, as noted in Appendix A, and to adopt the allocation of seats as noted in the appendix.
1.2 delegate the authority to the Head of Democracy Services to make appointments to the committees on the basis of political balance, and in accordance with the wishes of the political groups.
1.3 adopt the chairpersonships of scrutiny committees on the basis of political balance as follows, 2 Chairs for the Independent Group and 1 Chair for Plaid Cymru Group. An update of which Chair is to be allocated to which group will be made at the Full Council meeting.

1.4 adopt the higher salaries for 2022/23, and to ask the Democratic Services Committee to review the list for 2023/24.
1.5 confirm the allocation of the political groups support officers' posts and hours for the duration of this Council term unless a substantial change takes place in the political balance of the Council or that a political group has fewer than $10 \%$ of members.
1.6 adopt the seat allocation for the Snowdonia National Park Authority and the North Wales Fire and Rescue Authority for the term of this Council unless a review is
required because of changes in the political balance or a lack of commitment from an individual member.

## BACKGROUND AND RATIONALE

## 2. THE COUNCIL'S POLITICAL BALANCE

2.1. Following the May 2022 Local Government elections, the Gwynedd Council political balance is as follows:

| Group | Number |

| Independent | 23 |
| Individual Members | 2 |
| Total | 69 |

## ALLOCATION OF SEATS ON COMMITTEES

2.2. In accordance with this Council's procedures, a draft of the political balance was submitted for discussion by the Council's Business Group (namely a meeting of the Council's political group leaders). The Business Group's recommendations for seat allocation on the various committees are submitted in the Appendix to this report.

## 3. CHAIRMANSHIPS AND VICE-CHAIRMANSHIPS

3.1 The only committees for which the chairs are to be allocated on the basis of political balance are the Scrutiny Committees. There are specific rules to follow when calculating the scrutiny chairpersonship rights on the basis of political balance. The rules attempt to ensure that the groups that are not represented on the Executive are given a fair proportion of the chairpersonships. By following these rules, the chairpersonships are allocated as follows:

Independent Group - 2 chairs, Plaid Cymru Group - 1 chair.
3.2 The recommendation to attribute the Scrutiny Chairpersonships will be presented to the Council meeting:

## 5. POLITICAL GROUPS' SUPPORT OFFICERS

5.1 The hours of political support are allocated between the eligible groups as follows:

Plaid Cymru Group 36 hours
Independent Group 19 hours

## 6. OUTSIDE BODIES

6.1 It is the Council that decides on allocations of the seats to bodies that require political balance. There are two of these, namely

- Snowdonia National Park Authority, and
- North Wales Fire and Rescue Authority
6.2 The seats on the two outside authorities are allocated as follows:

6.3 The aforementioned allocation of seats will stand for the term of this Council unless a review is required due to a change to the political balance or a lack of commitment from an individual member. The political group leaders have received a copy of a protocol and job description for appointing to the roles on the National park, and roles on both outside bodies receive additional remuneration.
6.4 Police and Crime Panel. As stated in the original report, the Council is required to identify members to represent the Council on the Police and Crime Panel. The allocation as per political balance is not available to date, therefore I will report further on this matter to the Full Council meeting on $23^{\text {rd }}$ June, 2022.

## 7. ANY CONSULTATIONS UNDERTAKEN PRIOR TO RECOMMENDING THE DECISION

7.1 As usual, the Council's Business Group was consulted during although the timeframe was tight.
