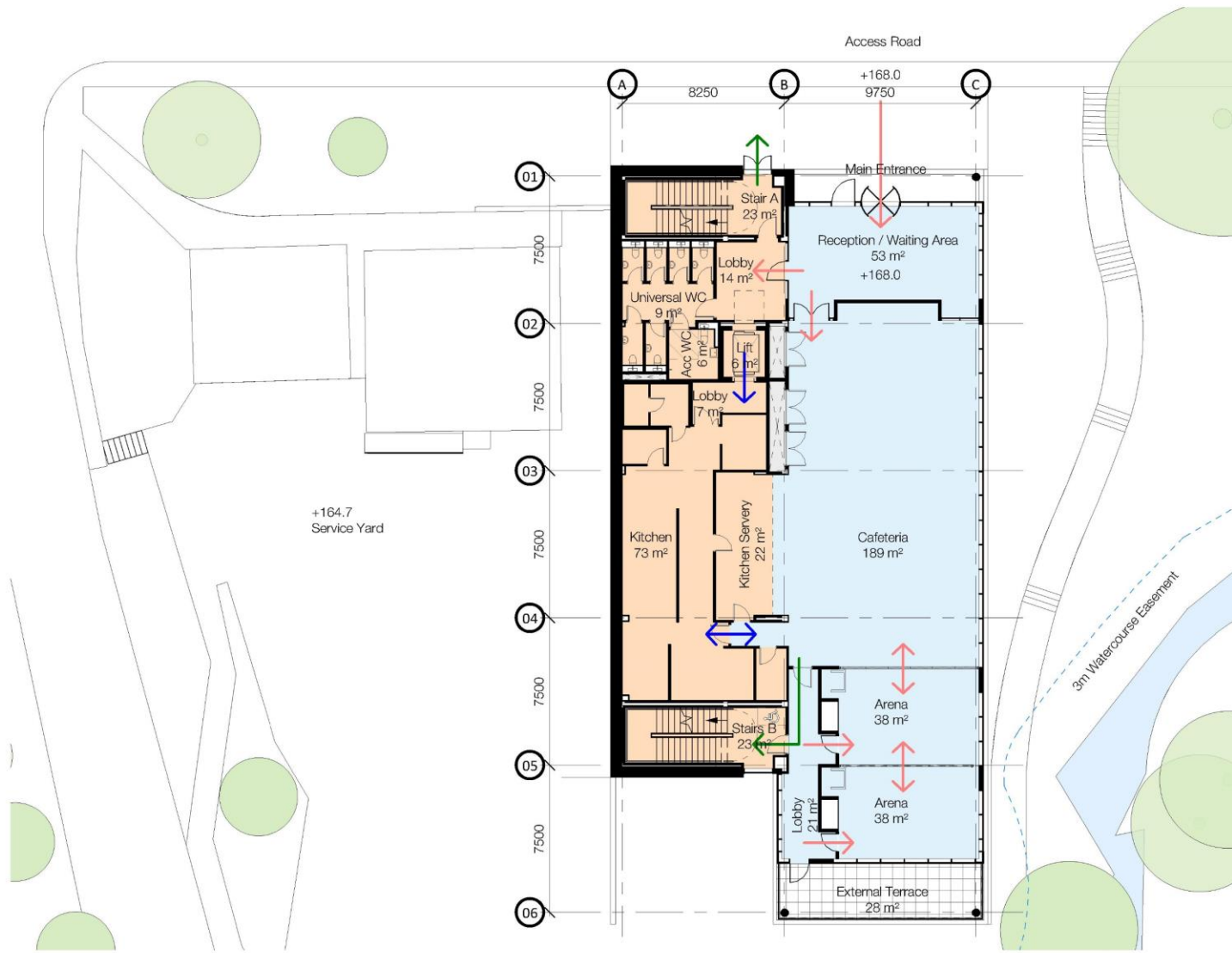


GA Plan - Level R1

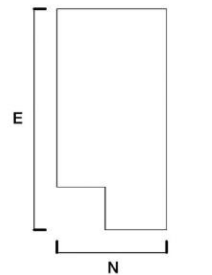
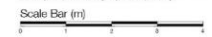


GA Elevation - North
